



#### URJ Statement: Standing Up for Voter Protection and Participation

We demonstrate our love by standing together with our allies at the NAACP, PICO National Network, and Lawyers' Committee for Civil Rights Under Law. Together, we are committed to protecting the right to vote and encouraging voter participation.

Our love is about justice and accountability. We will act with love by organizing to beat back efforts to suppress the vote across the United States. Unfettered access to the polls is a sacred aspect of American democracy and a fundamental component of racial justice....

## The 2013 Supreme Court decision *Shelby v. Holder* eviscerated the longstanding Voting Rights Act....

On Tu B'Av, Rabbi Rick Jacobs reminded us, "The God we love is impatient with injustice!" This November will mark the first presidential election in more than 50 years that lacks the full protection of the Voting Rights Act. We cannot allow the forces of racism and those who would constrict our democracy and shut people out of the process and decide who can and cannot vote.

From now through Election Day, the Reform Movement and our allies will be vigorously defending the right to vote and access to the polls, and we'll be doing our part to encourage and ensure high voter turnout.

# How does COVID-19 create issues with voting?

- People standing in long lines for hours waiting to vote, not socially distanced and some not wearing masks
- Fewer poll workers
- Fewer polling places
- So many people requested absentee ballots, not all received them
- Transportation issues
- Having to go farther to vote



## What Happened in Georgia and Wisconsin at Their Most Recent Elections?

- Absentee ballots were too late or did not arrive at all
- Polling places were closed or moved due to lack of poll workers
- Long lines waiting for hours
- Machines broke
- Some people were told they could not vote because polls closed while they waited.
- Tubs of absentee ballots were found at Wisconsin post offices

### Wisconsin Election, April 7, 2020

- Due to COVID-19 pandemic, 15 other US states cancelled or postponed their elections or primaries at the time of our election.
- Democratic lawmakers made several attempts to postpone the election but were prevented by Republican legislators.
- Gov. Evers called special session, but Republican leaders gaveled in and out within 17 seconds, criticizing the Governor for attempting to postpone the election and not calling a special session earlier.
- An Executive Order to postpone the election was blocked by the conservative State Supreme Court.

### Wisconsin Election, April 7, 2020

- SCOTUS blocked attempt to extend deadline for mailing absentee ballots.
- Many voters did not receive their requested absentee ballots.
- Some people were unable to get a required witness signature.
- Milwaukee Journal/Sentinel called the election the most undemocratic in the state's history, and put at risk everything gained from 3 weeks of staying home and keeping our distance.
- Our election debacle made national headlines and was shown on cable channels across the country and in Europe.

How can people vote safely during the pandemic?

- Curbside voting
- Early voting
- Expand vote-by-mail/absentee voting
- Ensure sufficient voting locations, especially in rural and tribal area

- ✓ Check to see if you are registered to vote
- ✓ Check your address
- ✓ Find the date of your next election
- ✓ Find your polling place
- ✓ View your voting history
- ✓ Find who your elected officials are
- ✓ Preview your next ballot
- ✓ Update your name or address
- ✓ Track your absentee ballot from request to delivery
- ✓ Register to vote
